



WILDLIFE HANDLING AND CHEMICAL IMMOBILIZATION COURSE

WOLF HAVEN INTERNATIONAL is hosting a 3-day wildlife handling and chemical immobilization course offered by **Mark R. Johnson, DVM** of *Global Wildlife Resources, Inc.* Dr. Johnson, former veterinarian of Yellowstone National Park, has participated nationwide in a wide range of wildlife handling field operations. He teaches wildlife professionals and students nationally including those at several universities and national parks and for many state and federal agencies. This is one of the most extensive chemical immobilization courses in North America and includes hand-on labs with captive wolves. **Space is limited!**

This unique training emphasizes:

- professional and humane animal handling,
- practical techniques to maximize field success,
- human and animal safety

Dr. Johnson will focus on the needs of researchers and managers to understand the skills and equipment associated with wildlife capture, physical restraint, and chemical immobilization. The course also covers in detail each aspect of animal handling such a radio-collaring, weighing, sample collection and patient monitoring.

Legal Responsibilities * Professionalism * Drug Delivery Systems * Immobilizing Drugs
Patient Monitoring * Marking * Sampling * Veterinary Emergencies
Euthanasia * Human Safety * Ethical Issues
Honoring each animal through equipment and techniques

The course is intended for federal, state and tribal wildlife personnel; zoo and sanctuary employees and volunteers; animal control officers; and university students. Course includes course notebook and labs each day. Participants will also receive a Certificate of Training upon course completion.
